Resolution #1 Roadmap for Enhancing the Djibouti Code of Conduct Information Sharing Network to Meet the Objectives of the Jeddah Amendment

THE DJIBOUTI CODE OF CONDUCT (DCoC) HIGH LEVEL MEETING ON IMPLEMENTATION OF THE JEDDAH AMENDMENT TO DCoC,

RECOGNIZING that Article 2 of the Jeddah Amendment calls for cooperation on information sharing in combating other maritime crimes which are transnational in nature,

ACKNOWLEDGING that Article 3 prescribes the measures at national level that are necessary for the success of collaboration as anticipated within the DCoC member states,

AGREES to implement basic minimum requirements in establishing National Maritime Information Sharing Centres (NMISC),

APPROVES in establishment, enhancement and operationalization of NMISCs, the establishment of National Maritime Security Committees, who will oversee them;

- RECOMMENDS to develop National Maritime Security Risk Registers as key components
 of National Maritime Security Strategies;
- 2. DECIDES on the DCoC Information Sharing Working Group minimum capability requirements for information sharing centres to be established within two years from the date of signing of these resolutions;

- DECLARES that NMISC will conduct self-assessments to determine their gaps and capabilities and report achievement of Initial Operational Capability to the Chair of Working Group One,
- ENDORSES the development, with the assistance of independent advisors, individual roadmaps to fully operationalise NMISCs;
- 5. INVITES Member States awaiting establishment of NMISCs, to focus on the development of clear SOPs for multi-agency information-sharing;
- 6. REQUESTS that the roadmap as identified will therefore involve, as minimum requirements to attain Initial Operational Capability for NMISCs:
- Doctrine and Concepts that depict the National Regional Mandate/Policy
- Minimum Infrastructure will include Building Facilities and Services
- ➤ That the anticipated MDA Capability will include MDA Systems necessary to support maritime security needs (National, Regional, International).
- > That the organization of the NMISC will include their Internal Manning Structure Roles and Responsibilities
- > That the Information to be exchanged will depend on the Data Available and Understanding
- That the focus of NMISC is cooperation across national agencies and Interoperability with the External Organisations
- That Member States further undertake to provide adequate personnel for their Manning and Operations
- > That NMISC will incorporate Training and standardization to enhance their capacity
- > That member states will provide minimum logistics for their operations that will involve Access, Transport, and a sustainable Financial Model
